# An Ordinance of the Palmer City Council Amending Palmer Municipal Code Chapter 2.25 Pertaining to Airport Advisory Commission

WHEREAS, the City Council adopted Ordinance No. 08-003, which enacted the Airport Advisory Commission (AAC); and

WHEREAS, the City Council recognizes the continued value the AAC brings to the Palmer community and wishes to provide clear guidance to the AAC through the Palmer Municipal Code (PMC); and

WHEREAS, the City Council periodically considers code amendments to assist in providing clear guidance; and

WHEREAS, the City Council adopted code amendments to Chapter 2.25 through Ordinance Numbers 14-005, 14-015, and 15-019.

THE CITY OF PALMER, ALASKA, ORDAINS:

<u>Section 1.</u> Classification. This ordinance shall be permanent in nature and shall be incorporated into the Palmer Municipal Code.

<u>Section 2.</u> Severability. If any provisions of this ordinance or application thereof to any person or circumstances are held invalid, the remainder of this ordinance and the application to the other persons or circumstances shall not be affected thereby.

<u>Section 3.</u> Palmer Municipal Code Chapter 2.25 is hereby amended to read as follows (new language is <u>underlined</u>, and deleted language is <del>stricken</del>):

#### 2.25.010 Purpose and duties.

The purpose of the commission includes the following:

- A. To assist in the development of plans for the airport;
- B. To recommend methods and means to implement airport plans;
- C. To assist in the promulgation of airport regulations;
- D. To work with and support city staff in the implementation of airport regulations; and
- E. To advance, promote and improve aviation development and opportunities.

#### 2.25.020 Creation.

- A. There is created a city airport advisory commission which shall consist of seven members.
- B. Commission Organizational Structure. The commission shall be structured as follows:
  - 1. At least two members shall reside within city limits be city residents; and
  - 2. At least three, but no more than four, shall have interests in the citymunicipal airport.

C. A person who leases real property (to include a tie-down space) at the airport or who uses the airport for any aircraft-related purpose is considered to be a person who has an interest in the airport.

#### 2.25.040 Compensation.

A. Each board commission member shall receive \$50.00 per regular and special meeting attended in person or by teleconference.

B. A commission member may decline compensation by completing the form required <u>as provided</u> by the city clerkto decline compensation.

#### 2.25.050 Staff assistance to commission.

A. The city manager or designee shall serve as staff to the commission.

B. The manager or designee will be the regular technical adviser of the commission and may also be designated its executive secretary, but the manager or designee shall not have the power to vote.

A. The city manager, or designee, shall assist the commission and will be the regular technical advisor of the commission, but shall not have the power to vote.

<u>B. City staff shall provide a recording clerk to the commission. The recording clerk shall keep a record of commission proceedings.</u>

#### 2.25.060 Quorum.

A quorum shall be made up of four members and be required to conduct a meeting, except that less than a quorum can adjourn a meeting to another time or date.

#### 2.25.070 Commission chair.

A. The chair shall preside at all commission meetings, and may participate in the debate, and vote on any matter of the commission.

B. In the temporary absence or disability of the chair, the vice chair shall exercise all the powers of chair-during the temporary absence or disability of the chair.

#### 2.25.080 Meetings.

A. <u>Public Participation</u>. All meetings are open to the public and shall be electronically recorded. T the public shall have the reasonable opportunity to be heard.

B. <u>Regular Meetings.</u> Regular commission meetings shall be held <u>at least quarterly</u> on the fourth Thursday of <u>eachthe</u> month beginning at 7:00 p.m. in the city council chambers, unless otherwise designated by the commission.

C. <u>Special Meetings</u>. A special commission meeting may be held at the call of the chair, any two members of the commission, or the city manager. No business shall be transacted at any special meeting except that which is specifically stated in the meeting notice.

D. Attendance and participation at meetings by commission members may be by teleconferencing. Materials that are to be considered at the meeting shall be made available at teleconference locations if practicable. The vote at a meeting held by teleconference shall be taken by roll call.

D. Teleconferencing.

1. A commission member who will be absent from a meeting may participate in and vote at the meeting by teleconference under the following circumstances:

a. Reasonable technical capabilities are available at the meeting location to allow the member to participate by teleconference, to include being able to hear and engage in discussion, and being audible to all persons participating in the meeting;

b. Prior to the meeting reasonable efforts are made to ensure that the member participating by teleconference is provided with the meeting agenda and other pertinent documents to be discussed and/or acted upon. Access to the agenda and documents from the city's website will be considered sufficient access; and

c. All votes taken at the meeting are by roll call.

2. Commission members may not use teleconferencing as a regular form of participating in meetings.

3. Commission members shall provide the chair and commission's technical advisor with at least twenty-four (24) hours' notice of their intent to participate in a meeting via teleconference and provide sufficient contact information for purposes of setting up the teleconference; unless another length of time for notice is agreed upon by the commission's technical advisor.

<u>4. Commission members are responsible for any charges incurred due to their participation in a meeting via teleconference.</u>

5. The chair may participate in meetings by teleconference but shall not act as presiding officer of the meeting.

E. <u>Adjournment.</u> The commission shall adjourn not later than <u>1110</u>:00 p.m. and may not reconvene any earlier than 9:00 a.m. the next day. However, by two-thirds consent of the commission the meeting may be extended for up to one hour, at which time adjournment is mandatory.

F. <u>Minutes</u>. Minutes shall be kept of the commission's proceedings. The minutes shall record the vote of each member upon every question. Every decision or finding shall immediately be filed in the city clerk's office and shall be a public record open to inspection by any person. <u>Minutes shall</u> be kept in accordance with best practices to ensure permanent retention of the record of proceedings and maintained in accordance with applicable local and state laws.

G. Report to the Council. The commission shall report-at least biannually to the city council on commission objectives and performance.

#### 2.25.090 Public meeting notification.

A. All public notices must include the date, time and place of a meeting, and if the meeting is by teleconference, the location of the teleconferencing facilities that will be used.

B. Regular Meeting. Public meeting notification shall be by means of <u>posting publishing</u> the agenda on the city's website and by publishing the agenda for a regular meeting five days prior to the <u>a regular</u> meeting.

C. Special Meeting. Public meeting notification shall be by means of <u>posting publishing</u> the agenda on the city's website and by publishing the agenda for a regular meeting three days prior to the <u>a special</u> meeting.

#### 2.25.100 Meetings – R<u>r</u>ules of proceedings.

Meetings shall be conducted under the current edition of Robert's Rules of Order, Newly Revised Edition.

#### 2.25.110 Audience participation.

All presentations to the commission shall be limited to three minutes per person, five minutes per group and also limited to a total time of not more than 30 minutes, unless the limitations are enumerable, in which case the presiding officer may set reasonable limits.

#### 2.25.120 Agenda and agenda packets.

A. The agenda for each meeting shall be prepared by the city manager, or designee, after consultation with the chair. The agenda shall include any discussion item requested in writing and signed by the chair or two commission members. The request shall be made to allow the timeframes of PMC 2.25.090.

B. The city manager, or designee, shall attempt to notify each commission member at least 48 hours prior to a regular meeting. Notification shall be by means of a packet including information on the time and place of meeting and the agenda. Whenever practicable, minutes of the previous meeting and other background material pertinent to the agenda shall be included in the packet.

#### 2.25.130 Voting.

A. The chair shall declare all votes.; but iIf any member doubts a vote, the chair, without further debate upon the question, shall request a roll call vote and the chair shall declare the result without further debate upon the question.

B. The vote upon all matters considered by the commission shall be taken by yes<u>/yea</u> or no<u>/nay</u> votes which shall be entered into the record, except that when the vote is unanimous, it shall be necessary only to so state.

C. Every member present shall vote, unless the <u>member is recused due to a declaration of conflict</u> of interest as stated in section 2.25.150 chair excuses the member because of substantial financial interest and the commission does not override the chair's action. Declarations to be excused must be made before the vote, and shall be decided without debate.

D. The affirmative or negative vote of at least four members shall be required for official action of the commission.

#### 2.25.140 Cause for removal.

A. A commission seat shall become vacant upon the occurrence of any of the following:

- 1. Expiration of the term of office;
- 2. Death of the commission member;
- 3. Resignation approved by the council;
- 4. Ceasing to possess the required eligibility qualifications to be a commission member;

5. Conviction of a felony involving moral turpitude or an offense involving a violation of an oath of office;

6. Judicial determination that the commission member is of unsound mind;

7. A decision of a competent tribunal declaring the appointment of the commission member void;

8. Failure to take an oath of office within 30 days of appointment to office or with such shorter time between appointment and the date of the commission member's first commission meeting; and

97. No longer physically resides in the city if it was a requirement of a member's appointment; orand

<u>108</u>. Other just cause for removal<u>, as determined by a majority vote of the city council</u>. B. In addition, a commission member may be removed by the council if, during any 12-month period while in office:

1. The commission member is absent from three regular meetings without excuse; or

2. The commission member is absent from six-regular meetings.

3. Absence from a meeting for good and sufficient cause shall be provided to the chair and commission's technical advisor prior to the meeting. The commission will determine if the good or sufficient absence is considered excused or unexcused by means of consent of the commission. The absence will be presumed unexcused if notification of the absence is not received prior to the meeting.

#### 2.25.150 Conflict of interest.

<u>A.</u> A commission member shall declare a substantial financial interest the member has in an official action prior to discussion and vote on the matter.

AB. The chair shall rule on the request to be excused from discussion and vote;.

<u>BC</u>. The decision of the chair on the request may be overridden by a majority vote <u>of the</u> <u>commission and shall be decided without debate</u>.

<u>Section 4.</u> Effective Date. Ordinance No. 19-017 shall take effect upon adoption by the city of Palmer City Council.

# An Ordinance of the Palmer City Council Amending Palmer Municipal Code Chapter 2.20 Pertaining to Planning and Zoning Commission

WHEREAS, the City Council adopted Ordinance No. 605, which enacted the Planning and Zoning Commission (PZC); and

WHEREAS, the City Council recognizes the continued value the PZC brings to the Palmer community and wishes to provide clear guidance to the PZC through the Palmer Municipal Code (PMC); and

WHEREAS, the City Council periodically considers code amendments to assist in providing clear guidance; and

WHEREAS, the City Council adopted code amendments to Chapter 2.20 through Ordinance Numbers 05-013, 06-022, 07-020, 14-004, 14-014, and 15-019.

THE CITY OF PALMER, ALASKA, ORDAINS:

<u>Section 1.</u> Classification. This ordinance shall be permanent in nature and shall be incorporated into the Palmer Municipal Code.

<u>Section 2.</u> Severability. If any provisions of this ordinance or application thereof to any person or circumstances are held invalid, the remainder of this ordinance and the application to the other persons or circumstances shall not be affected thereby.

C. Ordinances and Policies Concerning Subdivision of Land.

In exercising the powers granted it by this section, the commission may prepare and recommend for city council adoption ordinances and policies governing the subdivision of land within the city limits. Such ordinances and policies may provide for the harmonious development of the city and its environs; for the coordination of streets and other ways within the subdivided land with other existing or planned streets and ways and for conformance to the comprehensive plan or official map; for adequate open spaces; for spaces for traffic, utilities, recreation, light and air; and for the avoidance of congestion of population;

2. Subdividing, for the purposes of this section, shall be deemed to include the division of any lot, tract, or parcel of land into two or more lots, sites or other divisions of land for the purpose, whether immediate or future, of sale or building development;

- D. Perform duties as set out in PMC Title 17, Zoning; and
- E. Perform those duties established by the council from time to time.

#### 2.20.040 Compensation.

A. Each commission member shall receive \$50.00 per regular and special meeting attended in person or by teleconference.

<u>B. A commission member may decline compensation by completing the form required as provided</u> by the city clerk.

#### 2.20.050 Staff assistance to commission.

A. The city manager, or designee, shall assist the commission and shall be qualified by special training and experience in the field of city planning.

B. The city manager, or designee, will be the regular technical adviser of the commission, and may also be designated its executive secretary, but the city manager or designee shall not have the power to vote but shall not have the power to vote.

C. City staff shall provide a recording clerk to the commission. The recording clerk shall keep a record of commission proceedings.

Palmer Fire & Rescue is in the process of replacing firefighter personal protective equipment (PPE) that has or will reach its recommended life cycle in 2018/2019. National Fire Protection Association Standard (NFPA) 1851, *Standard on Selection, Care, and Maintenance of Protective Ensembles for Structural Fire Fighting and Proximity Fire Fighting* recommends PPE is removed from service ten years after the manufacture date of the ensemble. The PPE to be replaced was purchased in 2008/2009. This order will replace the PPE that is currently or soon to be expired equipment. The new PPE has extra built in protections to protect firefighters from the carcinogens encountered during firefighting operations.

The Fire & Rescue Department proposes to purchase the PPE through the local Lion vendor, Alaska Safety, Inc. This is to ensure compatibility with current PPE in the department inventory.

The PPE purchase will total \$33,900.00.

Mr. Best stated filling the vacancy was the most critical issue and the position does not give leeway for a learning curve, so due to the short time frame of the position, he was the most qualified amongst the applicants. He added city growth was the biggest issue the City was facing.

Question: What do you think is the most positive attribute of the City?

Mr. Best answered he thought the City had great city managers and government with the culture of the city employees, since he was part of hiring the city manager, city attorney, and city clerk.

Question: Share your assessment of any recent decision of the City Council.

Mr. Best answered he was always someone that talked about process and process was not followed for the new painted crosswalk. The public was not informed or had any input into the installation.

Applicant Jim Cooper's interview questions and answers were as follows:

Question: Tell us about yourself.

Mr. Cooper answered he was born and raised in Palmer, left for military service, him and his wife purchased Just Sew when they returned, and is now retired. He has served the Palmer community with the Chamber of Commerce, Planning & Zoning Commission, City Council as a council member and mayor, President of Alaska Municipal League, Palmer Citizen of the year in 1990, and Chair of Board of Economic Development.

Question: What do you feel is the most critical issue facing the City of Palmer today?

Mr. Cooper answered budget cuts and the four-lane highway were the most critical issues the city was facing. He stated the city needed to continue to be proactive and build on Palmers strengths, which were a sense of community, natural beauty, and quality of life.

Question: What do you think is the most positive attribute of the City?

Mr. Cooper answered Palmer was a great community and had good local events, which personifies the theme of Alaska At Its Best.

Question: Share your assessment of any recent decision of the City Council.

Mr. Cooper answered the Council should had taken a stand on the Governor's budget cuts due to the effect it would have on the City and the Borough.

Applicant Jill Valerus' interview questions and answers were as follows:

Question: Tell us about yourself.

Dr. Valerius answered she owned a local medical practice since 2014 and resided in the state for the last fifteen and half years, moving from Minnesota. She informed the Council the experience she brought was from her physician's standpoint of listening and empowering the community.

Question: What do you feel is the most critical issue facing the City of Palmer today?

Dr. Valerius answered community growth, fiscal responsibility to the community, and continual economic growth.

Question: What do you think is the most positive attribute of the City?

Dr. Valerius answered Palmer has a great history, which is distinguished compared to others.

Question: Share your assessment of any recent decision of the City Council.

Dr. Valerius answered the Council's plastic bag decision, in May 2018, was economic and environmentally friendly.

The Council adjourned from Committee of the Whole and reconvened the Regular Meeting at 8:20 p.m.













## Q7: How strong is your sense of community towards Palmer?









# Q10: Overall, how safe do you feel in your neighborhood?







#### Summary Statement/Background:

Palmer Municipal Code Title 17's definition of a brewpub allows a maximum of 50,000 gallons of beer to be brewed in one calendar year but requires a restaurant to be part of the brewpub. In Title 17, the definition of winery allows the manufacturing of a maximum of 50,000 gallons of wine in one calendar year for consumption off site without the requirement of a restaurant.

Wineries and Brewpubs are a conditional use in the CL – Limited Commercial District. In the CG – General Commercial District, a bar, cocktail lounge, liquor and beer sales, including brewpubs and wineries are a permitted use. Breweries are a permitted use in the Industrial and BP – Business Park District.

Title 17 does not have a definition for or addresses microbreweries for solely brewing small quantities of beer in one calendar year without a restaurant.

After brief discussion at the June 20 Planning and Zoning meeting, staff was directed to bring back a text amendment to define microbreweries and amend PMC 17.32 CG – General Commercial District to allow microbreweries as a permitted use.

The following was the proposed definition:

"Microbrewery" means a brewery, duly licensed by the State of Alaska, that brews a maximum of 15,000 gallons of beer on the premises in one calendar year.

At the July 18, 2019 Planning and Zoning meeting, the Commission reviewed the draft proposed ordinance to define microbreweries and allow them as a permitted use in the CG – General Commercial District. The Commission had discussion regarding the different types of breweries and the compatibility of microbreweries in the downtown area. After discussion and review of the draft Ordinance, the Commission voted unanimously to move the draft ordinance forward to City Council with a recommendation for adoption.

#### 17.08.296 Microbrewery.

"Microbrewery" means a brewery, duly licensed by the State of Alaska, that brews a maximum of 15,000 gallons of beer on the premises in one calendar year.

<u>Section 4.</u> Palmer Municipal Code Chapter 17.32.020(3) is hereby amended (new language is underlined and deleted language is stricken):

3. Bar, cocktail lounge, liquor and beer sales, including brewpubs, and wineries, and microbreweries;

#### Summary Statement/Background:

A concerned citizens group formed in Palmer and approached the Palmer City Council to consider adopting an excessive police response ordinance. The goal of the citizen group was to reduce criminal activity at problem locations in Palmer to which the police frequently respond.

This is a replacement ordinance for Ordinance No. 19-007 that was heard by public hearing on May 28, 2019. After the public hearing and discussion by Council it was moved that the ordinance be updated to reflect concerns on enforcement that were brought up by staff.

Modifications were drafted by staff and discussed with the citizens group on June 13 and discussed with Council during the committee of the whole discussion on code enforcement July 9. It was determined that this version was ready for a public hearing.

The intent of this ordinance is to hold both property owners and tenants accountable for repeated incidents of unlawful activity which take place on property for which they are responsible. Violation of this ordinance would result in a citation being issued to responsible parties once a certain number of calls for service for police verified unlawful activity is met.

WHEREAS, the city of Palmer has citizens concerned with residences that have an excessive amount of criminal activity and ordinance violations; and

WHEREAS, these citizens would like an avenue to discourage unlawful activities through a defined penalty system; and

WHEREAS, the Palmer police department is dispatched regularly to these problem residences for a variety of unlawful activities.

#### THE CITY OF PALMER, ALASKA, ORDAINS:

<u>Section 1.</u> Classification. This ordinance shall be permanent in nature and shall be incorporated into the Palmer Municipal Code.

<u>Section 2.</u> Severability. If any provisions of this ordinance or application thereof to any person or circumstances are held invalid, the remainder of this ordinance and the application to the other persons or circumstances shall not be affected thereby.

Section 3. Palmer Municipal Code Chapter 9.39 is hereby enacted to read as follows:

#### 9.39.010 Purpose

This ordinance addresses the issue of excessive police responses to repeat locations. Occasionally, one or more police officers respond multiple times to a property to a call for service regarding unlawful activity. This ordinance outlines liable parties and penalties for generation of excessive police response to such calls for service.

#### 9.39.020 Definitions.

When used in this chapter, the following words and phrases shall have the meanings set forth in this section:

"Dwelling unit" means a structure or portion thereof providing independent cooking, living, sleeping, and toilet facilities for a person or group of persons living as a single housekeeping unit.

"Excessive police response" means for a residential property, each police response as defined in this section, in excess of eight (8), to a dwelling unit in a calendar year.

"Mobile home" means a detached single dwelling unit fabricated at a factory and capable of being transported to location of use on its own chassis and wheels, identified by a model number and serial number by its manufacturer, and designed primarily for placement on a non-permanent foundation.

"Mobile home park" means any parcel or adjacent parcels of land in the same ownership which are managed for occupancy by more than two mobile homes. The term does not include tourist facilities for travel trailers or campers.

"Owner" means the record owner of the property as shown in the real property records of the borough.

"Person" means any individual, or any business or non-business association recognized by law, whether or not organized for profit.

"Police response" means one or more police officers that respond to a call for service which subsequent investigation determines is a violation of a Palmer Municipal Ordinance, Alaska State law of Federal Law. The term "police response" does not include a response to:

- 1. Receipt of false information as defined in AS 11.56.800(a)(1), unless the false information was provided by an occupant or owner of the property;
- A false alarm as defined in AS 11.56.800(a)(2) through (3), unless the false alarm was caused, permitted or allowed by an occupant or owner of the property in violation of AS 11.56.800(a)(2) through (3);
- 3. A call involving potential child neglect, potential domestic violence as defined in AS 18.66.990, or potential stalking under AS 11.41.260 or 11.41.270;
- 4. A report of a sexual assault as defined in AS 11.41.410 through 11.41.427;
- 5. A call from the tenant or owner of property for police assistance with:
  - a. Theft or attempted theft from the tenant or owner; or
  - b. A report of the presence or identification of a person under state or federal warrant; or
  - c. An inebriated person preparing to operate a motor vehicle upon leaving the premises.

"Residential property" means an individual parcel, tract or lot shown on the most recent plat of record containing one or more dwelling units, or a mobile home.

#### 9.39.030 Notice to liable persons.

A. The city shall notify the owner and tenant of a property in writing when the number of police responses in the current calendar year to a residential unit reaches six (6). When the number of responses reaches eight (8), the owner and tenant shall be notified by the City that subsequent qualifying calls may result in a citation being issued to appropriate individuals.

B. A notice under this section shall be given in a manner reasonably calculated, under all the circumstances, to provide actual notice to the person of the potential liability for citation. At a minimum, the notice shall be sent by certified mail or by direct delivery, return receipt requested, to the mailing address of the person as shown on property tax records. If the mailed notice is returned refused for signature by the recipient, actual notice shall be conclusively presumed on

the date refused. If the mailed notice is returned unclaimed or undeliverable, the city shall accomplish notice by another method and attest to the date notice is accomplished by affidavit or in a police report. Notice may be accomplished by any lawful manner.

C. The notice addressed to an owner and tenant shall:

1. Identify the property that is the subject of the notice by street address, and if the property has multiple units, identify the dwelling unit;

2. State the number of police responses in the calendar year to date and state additional police responses to the unit or property may result in the issuance of a citation under this chapter;

3. State the person shall be liable for additional citations for each excessive police response to the property during the calendar year;

4. State the amount of the citation per excessive police response; and

5. State the contact information of a representative of the police department to contact concerning the notice.

#### 9.39.040 Citation for excessive police response.

Is it unlawful for the owner or tenant of a dwelling or residential property to cause excessive police responses as defined in PMC 9.39.020.

A. The police department shall serve the owner of the property and the tenant of a unit a citation for excessive police responses.

B. A person is exempt from liability for the citation established by subsection (A) of this section if:

1. The person is a federal, state, or local government agency;

2. The property or unit responded to is used exclusively for nonprofit religious, charitable, cemetery, hospital or educational purposes;

3. The city has not provided notice to the person in writing as provided in PMC 9.36.030;

C. If a property has more than one owner, all owners shall be jointly liable, with the tenant, for any citation issued under this chapter. Actual notice to one owner creates a rebuttable presumption of actual notice to all other owners.

D. For residential property owned as a condominium, a citation based on excessive police responses to a single dwelling unit shall be assessed against the owner of the dwelling unit, jointly with the tenant.

E. A tenant shall not be liable for a citation if the tenant's conduct did not require the police response and the tenant's right to possession commenced on a date subsequent to the date of the first police response that is counted for purposes of the fee imposed under this chapter.

F. If the unit requiring excessive police responses is a mobile home located in a mobile home park, the fee may not be imposed on the owner or operator of the mobile home park unless the owner's or operator's conduct required the excessive police response, or if the mobile home is owned and rented out by the mobile home park owner. The fee may be imposed jointly on the owner and tenant of the mobile home.

G. The cost of the citation may be collected in accordance with applicable rules of court and Palmer Municipal Code.

<u>Section 4.</u> Effective Date. Ordinance No. 19-016 shall take effect upon adoption by the City of Palmer City Council.


