Meeting with Engine 557 Restoration Company

On January 13 City Manager John Moosey, Community Development Director Brad Hanson and I met with Pat Durand (557 Founder) and Lamarr Anderson (557 Community Outreach Director) of the Engine 557 Restoration Company. We had some robust discussions of their future plans and they are working on compiling operational details to bring back to us in a few months. Here's a summary of the highlights:

- 2023 is the Alaska Railroad's centennial year -- "Alaska Railroad: 100 Years Strong" is their theme and the 557 group is working on some celebratory short runs north and sound from Anchorage in the next few years.
- As the near completion of the the 557 Restoration, a next step for 557 would be to test drive 557 on actual track. They are interested in working to clear brush, inspect and test run 557 on our Airport "Branch Line" in the near future.
- One of their long term desire/goals is to have 3 regular weekend runs from the Palmer Depot to the old Matanuska townsite.

Palmer Mayor's Report

I see working with the 557 Project in phases:

Con: Rail service at the Depot (Phase 4)

I am a railfan, but I have serious concerns about how regular rail service to the depot would affect our traffic patterns in downtown. I have concerns when we block off a couple blocks of major streets for more than a few hours. I am not ready to ask to go "down this track" at this time. This is what I would call Phase 4.

Pros: Palmer Airport Branch (Phase 2)

Our Airport Branch Line has been out of service for some years. The city actual owns the right-of-way for the Airport Branch, kind of. There is some type of 3-way understanding between the Federal Railroad Administration (government oversight?), Alaska Railroad (they own the rails), and the City of Palmer (we own the land/ROW).

With more information from 557 we may be able to come up with understanding or even agreement between the FRA, AKRR, 557 and City of Palmer. This would involve more sweat equity (labor) then money. I would call this Phase 2 and very doable.

Pros: Rail service to the Pioneer Home? (Phase 3)

Our previous mayor was exploring the idea of doing a collaborative Veterans Memorial near the Pioneer Home possibly on Alaska Railroad ROW. I've expanded the idea of what if it included a small train station as well. To do this would involve a couple of crossings at Springer 1 and Commercial Drive but would stop trains at Fireweed. This would involve money and agreements between multiple parties and sweat equity (most things with railroads include sweat equity i.e. hard work).

Palmer Mayor's Report

BTW, in my mind I consider Phase 1 the full restoration of Engine 557. I am not saying we wouldn't get to the point of having an engine at the depot. I just don't think we are ready to commit to this idea at this time. I would like to have some robust discussions with our city staff on traffic patterns downtown and ideas for improving what we have already.

I still like trains and like the idea of at least getting trains to within sight of downtown.

With the snow-me-geddon of December, we postponed the Resource Day. It has been scheduled for Thursday, February 16 at the Palmer Depot.

Polly Beth Odom of Daybreak Inc. will be inviting groups they partner with to be there. I also still want to invite nonprofits, churches and businesses and individuals that are interested in working with the homeless.

My idea is that the people of Palmer would learn what issues there are with the homelessness and to consider how they can get involved. Attached is a flyer for this event.

Summary Statement/Background:

This resolution requests the authorization to purchase one new RPM220 Loader Mounted Snow Blower from BSI Equipment, LLC.

The City needs to replace its existing snow blowers. The age of these blowers makes them unreliable, and parts are extremely difficult to find. This new blower will replace a blower that is 42 years old. This new blower will be used to aid the city in the clearing of city streets, parking lots, and snow dumps.

The City of Palmer Administration chose this snow blower as a direct replacement of the oldest existing unit and to take advantage of the existing Sourcewell Government contract.

3.21.230 Governmental and proprietary procurements.

A. The purchasing officer may contract, without the use of the competitive source selection procedures of this chapter, for the following supplies, services, professional services, or construction:

1. For contracts, including reimbursable agreements, with federal, state, or local units of government or utility provider where the city has a financial responsibility or beneficial interest in entering into an agreement.

2. For contracts issued pursuant to any federal, state, or local government contract where the city is an authorized user, or where the resulting contractor agrees to extend the same terms, conditions, and pricing to the city as those awarded under the original contract, all in accordance with PMC 3.21.240. Such agreements shall be limited to those contracts where the award is issued pursuant to a formally advertised solicitation.

3. For contracts where the purchasing officer determines in writing that the city's requirements reasonably limit the source for the supplies, services, professional service, or construction to one person.

B. All contract awards under this section, and any amendments thereto, shall be subject to applicable approval requirements of PMC 3.21.090 prior to execution.

C. No contractor may provide supplies, services, professional services, or construction to the city before the applicable requirements of this section are first satisfied. (Ord. 644 § 4, 2004)

The funds to purchase this snow blower will come from the General Fund unassigned fund balance. Unaudited estimated year end 2022 General Fund unassigned fund balance is just under \$8 million.


