

## **PALMER POLICE PRESS RELEASES FOR November 30- December 6, 2020**

On November 30, 2020, Palmer Police received a report that a passenger side window and mirror on a vehicle was damaged. The damaged was estimated to be over \$250.00.

On December 2<sup>nd</sup> 2020, Palmer Police Department arrested WILLIAM C.L. JOHNSON, age 37 of Wasilla, on a \$250.00 Warrant for Failure to Comply with conditions of release with an original charge of Misconduct Involving a Controlled Substance 5.
