

## **PALMER POLICE PRESS RELEASES FOR May 18-24, 2020**

On May 18, 2020, Palmer Police issued summons to MARK ALLEN WOOD, age 43 of Palmer, and TRINITA MAHEALANI KAPUAALA, age 26 of Anchorage, for Burglary in the second degree.

On May 20, 2019, Palmer Police responded to a Motor Vehicle Collision at the intersection of Arctic Avenue and the Glenn Highway. KEMP was remanded to Mat-Su Pretrial where bail was set at \$2000.

On May 23, 2020, Palmer Police arrested CHRISTOPHER B. ANDERSON, age 29 of Wasilla, for Failure to Stop at the Direction of a Peace Officer 1. CHRISTOPHER was additionally arrested on a warrant for Failure to Appear at Sentencing with an original charge of Misconduct Involving Weapons 3 and Theft 2. CHRISTOPHER was remanded to Mat-Su Pretrial where he was held without bail.

On May 23, 2020, Palmer Police Summoned JERI D. MCDONALD, age 40 of Palmer, for Concealing Merchandise and for Violating Conditions of Release. She was released from the scene on her own recognizance, per the modified Covid-19 bail schedule.

On May 23, 2020, Palmer Police arrested RICHARD J. RUCKER, age 21 of Palmer, for Assault 3. He was remanded to Mat-Su Pretrial where he was held without bail.
