

## **PALMER POLICE PRESS RELEASES FOR MARCH 16-22,** **2020**

On March 15, 2020, Palmer Police arrested TIMMOTHY D. JOHNSON, age 36 of Palmer, on a \$300.00 warrant for Failure to Appear for Arraignment on the original charges of Criminal Trespass 2 and Resisting Arrest. He was remanded to Mat-Su Pretrial.

On March 16, 2020, Palmer Police arrested ROBERT KULL, age 52 of Wasilla, on a \$10,000.00 warrant for Failure to Comply with Conditions of Probation on the original charge of Driving Under the Influence.

On March 16, 2020, Palmer Police arrested BRANDI SHERE HARDON, age 36 of Wasilla, on a \$20,000.00 warrant for Failure to Comply with Conditions of Probation on an Original Charge of Contempt of Court.

On March 17, 2020, Palmer Police arrested HUNTER L. TAMEZ, age 26 of Palmer, for Driving While License Revoked, Misconduct Involving Controlled Substance 5, and Violating Conditions of Release. He was remanded to Mat-Su Pretrial and held on \$250.00 bail, per the bail schedule.

On March 17, 2020 Palmer Police investigated a fatal vehicle versus pedestrian accident on the Glenn Highway. The identity of the deceased is being withheld pending notification of the next of kin. The driver INDIA G. WILLIAMS, age 28 of Palmer, was not injured in the crash. No charges were filed.

On March 18, 2020, Palmer Police arrested AMANDA EDWARDS, age 21 of Anchorage, for Disorderly Conduct and Violation of Conditions of Release. She was remanded to Mat-Su Pretrial where she was held on \$250.00 bail per the bail schedule.

On March 20, 2020, Palmer Police arrested SHANE M. MADSEN, age 38 of Palmer, for Disorderly Conduct and Violating Conditions of Release. MADSEN was remanded to Mat-Su Pretrial where bail was set at \$250.00 per the bail schedule.

On March 20, 2020, Palmer Police received a report of stolen valued at \$396.00. Investigation continues.

On March 19, 2020, Palmer Police arrested ANTHONY A. HAYS, age 67 of Kodiak, for Criminal Trespass in the Second Degree and Violating Conditions of Release. HAYS was remanded to Mat-Su Pretrial where he's to be released on his own recognizance per the bail schedule.

On March 20, 2020, Denise Cathleen Garrettson, age 48 of Palmer, was Indicted by a Palmer Grand Jury for Theft 1, Fraudulent Use of Access Device over \$25,000; Theft 2; Fraudulent Use of Access Device over \$1000 but less than \$25,000. The Indictment stemmed from an investigation conducted by Palmer Police after receiving a report by Palmer Amateur Hockey Association (PAHA) board members, that a substantial amount of money was missing from the associations bank account. Garrettson served as the PAHA's Treasurer.

On March 21, 2020, Palmer Police arrested TRE A. KRZYNOWEK, age 28 of Wasilla, for Misconduct Involving a Controlled Substance 2, Misconduct Involving Weapons 2, Misconduct Involving a Controlled Substance 4, Misconduct Involving a Controlled Substance 4, and Failure to Register as a Sex Offender 2. KRZYNOWEK was remanded to Mat-Su Pretrial where he was held without bail per the bail schedule.

On March 21, 2020, Palmer Police arrested HUNTER L. TAMEZ, age 27 of Palmer, for Driving While License Revoked and Violating Conditions of Release. TAMEZ was remanded to Mat-Su Pretrial where bail was set at \$1000.00 cash performance, per the bail schedule.

On March 21, 2020, Palmer Police recovered a 2004 Green Chrysler Town and Country that was reported stolen out of Anchorage.
