

## **PALMER POLICE PRESS RELEASES FOR February 17-23,** **2020**

On February 17, 2020, Palmer Police arrested MICHAEL LAKE, age 29 of Palmer, for Driving Under the Influence and Refusal to Submit to a Chemical Test. He was remanded to Matsu Pretrial Facility without bail.

On February 18, 2020, Palmer Police investigated a Motor Vehicle Collision at the intersection of West Dahlia Street and South Alaska Street. The drivers were identified as APRIL ANN BROWN, age 45 of Wasilla, and KENNETH DALE ALBERTSEN, age 54 of Palmer.
