

PALMER POLICE PRESS RELEASES FOR February 10-16, **2020**

On February 10, 2020, Palmer Police responded to a theft of alcohol from Palmer Oaken Keg. A 15 year old Palmer male was contacted and charges of Theft in the 4th Degree were forwarded to Juvenile Justice. Estimated value of the theft was \$30.00.

On February 10, 2020, Palmer Police Summoned BERT A. TEMPLE, age 63 of Palmer, for Duty of Operator to Give Information (Hit & Run).

On February 10, 2020, Palmer Police investigated a 2 vehicle Motor Vehicle Collision at the intersection of Arctic and Valley. One person complained of injury and was seen at the scene by EMS.
