

PALMER POLICE PRESS RELEASES FOR January 20-26, **2020**

On January 20, 2020, Palmer Police arrested KYLE NEELEY, age 29 of Soldotna, on a \$500.00 warrant for Failure to Appear at Arraignment for an Original Charge of Improper Use of Registration/Title/Plates. He was remanded to Mat-Su Pretrial.

On January 20, 2020, Palmer Police arrested TERRA R. STANLEY, age 43 of Palmer, for Criminal Trespass II and Violating Conditions of Release. She was remanded to Mat-Su Pretrial and held on \$250.00 bail.
