

PALMER POLICE PRESS RELEASES FOR January 13-19, **2020**

On January 13, 2020, Palmer Police arrested LONNY L. RICHMAN, age 40 of Palmer, on a \$100 cash warrant for Failure to Appear for Pretrial Conference on January 6, 2020 from original charges of Disorderly Conduct. RICHMAN was remanded to Mat-Su Pretrial.
