October 28 – November 3, 2019

On October 28, 2019, Palmer Police arrested ROBERT W. MALONE, age 48 of Palmer, on a \$500 warrant for Failure to Appear at a CRP Hearing on an original charge of Assault 4. MALONE was also charged with Violating Conditions of Release. MALONE was remanded to Mat-Su Pretrial where he was held without bail on the new charge.
