June 3-9, 2019

On June 3, 2019, Palmer Police arrested CHRISTOPHER J. PERRY, age 22 of Palmer, for Driving Under the Influence and Violating Conditions of Release. PERRY was remanded to Mat-Su Pretrial where bail was set at \$250.

On June 3, 2019, Palmer Police arrested NATHANIEL L. SCHMOE, age 26 of Anchorage, for False Information. SCHMOE was also arrested on \$40,000 in warrants for Failure to Comply with Conditions of Probation on Original Charges of Theft 2 and Assault 1. SCHMOE was remanded to Mat-Su Pretrial.
