November 30-December 6, 2015

On November 30, 2015, Palmer Police arrested JASON W. IRWIN, age 46 of Palmer, on two no bail warrants for Failure to Remand on original charges of Driving While License Revoked and Violating Conditions of Release.

On November 30, 2015, IVAN KRASKOFF, age 48 of Palmer, reported jewelry had been stolen from his residence in Palmer. The investigation is continuing.
