November 9-15, 2015

On November 9, 2015, Palmer Police received a report of checks that had been forged. The investigation is continuing.

On November 11, 201, Palmer Police arrested a 30 year old woman of Palmer for Domestic Violence Assault 4. She was remanded to Mat-Su Pretrial with no bail.

On November 10, 2015, Palmer Police issued NICHOLAS K. JAY, age 33 of Palmer, a summons for Texting While Driving and Driving While License Suspended.

On November 10, 2015, a 36 year old female of Palmer reported being assaulted.

On November 11, 2015 Palmer Police responded to report of underage drinking and trespass of a local residence. Following an investigation KAYLEE SHAYE DEMIENTIEFF, age 18 of Palmer, was arrested for Furnishing Alcohol to a Minor, Hindering Prosecution 2 degree, and Minor Consuming Alcohol.
