May 25 -31, 2015

On May 25, 2015, Palmer Police received the report of a motor vehicle collision in the area of the Glenn Highway and West Dogwood Avenue involving STEVEN F. ARNOLD, age 68 of Eagle River, and JONATHAN R. PITTMAN, age 21 of Anchorage. Minor injuries were reported.
