

Press Releases January 5-11, 2015

On January 5, 2015, ROBERT D. JACKSON, age 52 of Palmer, collided with a vehicle being driven by MATTHEW J. WAUTELET, age 36 of Palmer, in the intersection of Evergreen Avenue and the Glenn Highway. Minor injuries were reported.

On January 5, 2015, Palmer Police responded to the report of a collision on West Dogwood Avenue at South Cobb Street involving PATSY F. RAEBER, age 74 of Wasilla, and CASSANDRA M. BLAWAT, age 25 of Palmer. No injuries were reported.

On January 6, 2015, LONELLE N. MOORE, age 33 of Palmer, was arrested on a \$500.00 warrant for Contempt of Court, Fail to Comply with Conditions Probation, original charge Driving While License Suspended.

On January 6, 2015, a 12 year old female from Palmer assaulted her 46 year old mother from Palmer. Charges will be forwarded to the Juvenile Justice Division.

On January 10, 2015 Palmer Police arrested JACQUELINE GOODWIN, age 29 of Anchorage, for Theft of Services, Shoplifting and Violating Conditions of Release. Goodwin was remanded to Mat-Su Pretrial where she was held without bail until arraignments.
