

## **Press Releases October 20-26, 2014**

On October 20, 2014, Palmer Police arrested a 44 year old male of Palmer for Domestic Violence Assault in the 4<sup>th</sup> Degree. He was remanded to Mat Su Pretrial and held without bail per the bail schedule.
