

Press Releases October 6-12, 2014

On October 6, 2014, Palmer Police arrested 24 year old BRIAN ANTHONY KLOSS of Wasilla for a \$1500 outstanding warrant. The warrant was issued for Violating Court Conditions. KLOSS was remanded to Mat-Su Pretrial on the \$1500 and a Court Approved Third Party.

On October 7, 2014, Palmer Police issued 17 year old TANNER KEITH HOOKS of Palmer a summons for Driving Without a Valid Driver's License.
