### **September 22-28, 2014**

On September 22, 2014, Palmer Police arrested GLENN S. ARMSTRONG, age 52 of Palmer, on a \$250.00 warrant for Failure to Comply with ASAP Probation, original charge Refuse to Submit to Chemical Test.
