

Press Releases September 15-21, 2014

On September 15, 2014, Palmer Police arrested ALICE D. LEE, age 31 of Palmer, on a \$2500.00 cash/corporate warrant for Failure to Appear Bail Hearing, original charge of Fraudulent Use of Access Device.

On September 15, 2014, Palmer Police arrested BRIDGET H. HOLLAND, age 28 of Palmer, on a \$100 cash/corporate warrant for Failure to Appear Arraignment, original charge of Texting While Driving.

On September 15, 2014, Palmer Police received a report that \$720.00 in cash was stolen from a wallet in the parking lot of Fred Meyer.

On September 15, 2014, Palmer Police responded to the report of a collision on West Evergreen Avenue at South Dimond Street involving BRIDGET H. HOLLAND, age 28 of Palmer, and HELENE M.
