

Press Releases July 14-20, 2014

On July 14, 2014, Palmer Police arrested JOSEPHINE L. ARCHULETA, age 18 of Noatak, for Minor Consuming Alcohol and False Report. ARCHULETA was remanded at Mat Su Pretrial where she was ordered held until arraignment by Magistrate Clark.

On July 14, 2014, Palmer Police responded to the Palmer Wasilla Highway at Rowland Memorial Way for a two vehicle collision involving ROBERTA R. GOULD, age 40 of Palmer, and AUSTON S. HUNSUCK, age 18 of Wasilla. No injuries were reported.
