

## **PRESS RELEASE FOR JUNE 27- JULY 3, 2016**

On June 27, 2016, FANETTA E. HIGLEY, age 47 of Palmer reported a theft of property from her residence. The estimated value of the stolen property was \$22.66

On June 27<sup>th</sup>, 2016, First National Bank Alaska turned over a counterfeit \$100 bill. The bill will be forwarded to the US Secret Service.

On June 28, 2016, Palmer Police arrested DUSTIN TYLER DANIELS, age 26 of Wasilla, on a \$20,000.00 warrant for Failure to Comply With Conditions of Probation, Original Charge of Felony Driving Under the Influence.
