## June 6-12, 2016

On June 6, 2016, Palmer Police responded to a Palmer residence for a 48-year-old woman who had been bitten by a dog.

On June 7, 2016, Palmer Police issued a Summons to JODECEI C. ASLAKSON, age 18 of Palmer, for Driving Without a Valid License.
