## April 18-24, 2016

On April 18, 2016, Palmer Police responded to a single airplane accident at the Palmer Airport. The pilot was identified as GARY A. JAMISON, age 67 of Eagle River. JAMISON was treated for minor injuries by on scene medics.

On April 18, 2016, Palmer Police received a report from JAMES G. GREER, age 23 of Fairbanks, that his vehicle was hit by another vehicle while it was parked in a parking lot. The suspect vehicle left the scene.

On April 19, 2016, Palmer Police arrested MISTY M. POTTEIGER, age 38 of Palmer, for Criminal Mischief 5 (Domestic Violence). POTTEIGER was remanded to Mat-Su Pretrial without bail.
