## March 21-27, 2016

On March 21, 2016, Palmer Police arrested RODNEY A. HUYSMAN, age 54 of Palmer, on a no bail warrant for Failure to Remand on an original charge of Driving Under the Influence. He was remanded to Mat-Su Pretrial.
