February 22-28, 2016

On February 22, 2016, Palmer Police responded to a motor vehicle collision at the intersection of Glenn Highway and Evergreen Avenue. The drivers were identified as RUDY JOHN MARTINEZ, age 32 of Palmer, and PATRICK JAMES WISE, age 24 of Palmer. There were no reported injuries.
