February 8-14, 2016

On February 8, 2016, Palmer Police arrested JEFFREY CHAD KUDLACEK, age 23 of Sutton on a \$20,000 warrant for Probation Violation on an original charge of Failure to Comply with Conditions of PACE Program on Assault 3. He was remanded to Mat-Su Pretrial.
