

Press Releases March 3-9, 2014

On March 3, 2014, Palmer Police arrested ANTHONY P. DRAINNO, age 29 of Palmer, for Driving Under the Influence. He was remanded to Mat-Su Pretrial and held on \$500.00 bail.
