

## **Press Releases January 13-19, 2014**

On January 13, 2014, ANDREW SCOTT MCBATH, age 25 of Wasilla, reported his vehicle had been struck while parked at a local business and the other unknown vehicle had left the scene.

On January 13, 2014, ALLEN KENNETH THEODORE, age 53 of Willow, was arrested for an outstanding No Bail warrant for Parole Violation on the original charge of Felony DUI, Felony Refusal, and MIW 4.

On January 13, 2014, CARRS Quality Center of Palmer reported damage to exterior of the building.

On January 15, 2014, Palmer Police arrested CAMILO RAY NANTES II, age 34 of Wasilla, for a \$250 warrant for Failure to Appear for Arraignment on the original charge of Permitting an Unauthorized Person to Drive. It was later discovered that NANTES also had a no bond warrant from Montana for Violating Conditions of Release on the original charges of Robbery and Theft. NANTES was held pending extradition as a Fugitive from Justice at Mat Su Pre Trial.
