March 27 – April 2, 2017

On March 27, 2017, Palmer Police arrested Gregory D. Adams, age 42 of Palmer, for Driving While Driver's License Revoked. Adams was remanded to Mat Su Pretrial Facility where he was released on his own recognizance.
