

## **Press Releases December 2-8, 2013**

On December 2, 2013, Palmer Police issued a summons for Driving Without a Valid Operator's License to JESSICA C. BLAWAT, age 22 of Palmer.

On December 3, 2013, Palmer Police arrested 43 year old Wasilla resident, CYNTHIA MARIE DURK. DURK had a \$1500 warrant for Failure to Appear, original charges Assault IV and Theft IV. DURK was remanded to Mat Su Pretrial facility.
