November 25-December 1, 2013

On November 25, 2013, JOHN THOMAS, age 34 of Palmer, was arrested on a \$5,000 warrant, with Court Approved Third Party, on the original charge of Vehicle Theft I.

On November 25, 2013, ANICKIE IVANOV, age 20 of Palmer, was arrested for Driving Under the Influence and Reckless Driving. He was remanded at Mat Su Pretrial Facility on \$1000 bail.
