

PALMER POLICE PRESS RELEASES FOR **February 1-7, 2021**

On February 2, 2021, Palmer Police arrested JON R. HALLER, age 67 of Palmer, for Disorderly Conduct. HALLER was remanded to Mat-Su Pretrial where he was held without bail until arraignment plus a third party custodian.

On February 3rd, 2021, Palmer Police responded to the report of a single vehicle rollover involving RAEVYN MARTIN-CORDERO, age 18 of Palmer, on E. Arctic Avenue by the Matanuska River Bridge. There were no injuries and the vehicle was towed due to disabling damages.

On February 3rd, 2021, Palmer Police charged a 40 year old Palmer man for Violation of a Domestic Violence Protective Order. Charges were forwarded to the District Attorney's Office.

On February 4, 2021, THOMAS V. JAMGOCHIAN, age 43 of Palmer, reported hit and run damage to his vehicle at the Carrs parking lot. Investigation continues. Approximate damage is valued at \$500.00.

On February 5, 2021, Palmer Police received a report of a possible Fraud valued at \$2500.00. Investigation continues.

On February 5, 2021, NANCEY M. TYLER-HESS, age 64 of Palmer, reported hit and run damage to her vehicle that likely occurred in Palmer during the week of January 20. Investigation continues.

On February 5, 2021, Palmer Police Summoned LAUREN L. TOOYAK, age 31 of Palmer, for Driving Under the Influence, Failure to Stop at the Direction of a Peace Officer 2, and three counts of Endangering the Welfare of a Child 1.

On February 5, 2021, Palmer Police received a report of a theft from a residence in Palmer. Value of the stolen property is currently unknown. The investigation is currently ongoing.

On February 6, 2021, Palmer Police responded to the intersection of the Glenn Highway and W. Evergreen Avenue for a report of a 2 vehicle motor vehicle collision. The drivers were identified as ALEXA T. LACHELT, age 30 of Palmer, and JOSEPH P. BOWLIN, age 32 of Palmer. No injuries were reported, and investigation led to BOWLIN being charged with Driving While License Revoked and No Motor Vehicle Operator Insurance. BOWLIN was issued a Summons to appear in court and released from the scene, per the bail schedule.

On February 6, 2021, Palmer Police received a report of a theft of a wallet from the Palmer Carrs grocery store. Stolen cash value was \$20.00. Investigation continues.

On February 7, 2021, Palmer Police investigated a single vehicle motor vehicle collision at Evergreen Avenue and S. Colony Way. An investigation determined HUNTER OLSON, Age 19 of Palmer, was involved in a motor vehicle collision with a parked vehicle and a light. Olson was transported by EMS to Mat-Su Regional Medical Center with suspected minor injuries. Both vehicles were towed from the scene.
