

PALMER POLICE PRESS RELEASES FOR **March 1-7, 2021**

On March 1, 2021, Palmer Police arrested ROSEBUD L. SWEENEY, age 30 of Palmer, for Violating Conditions of Release and Criminal Trespass 2. She was remanded to Mat-Su Pretrial where she was held on \$25 bail.

On March 2, 2021, Palmer Police arrested JAMES D. WELLS Jr., age 24 of Palmer, on a \$50.00 warrant for Failure to Appear on the original charge of No Liability Insurance.

On March 2, 2021, Palmer Police Summoned ZACHARIAH COOK, age 21 of Anchorage, was for Criminal Trespass 2 and Theft 4. He was released on his own recognizance.

On March 3, 2021, Palmer Police arrested ALISON J. HOOKS, age 37 of Wasilla, on a \$50.00 warrant for Failure to Appear at Pretrial Conference with an original charge of Misconduct Involving a Controlled Substance 5.
