

PALMER POLICE PRESS RELEASES FOR **March 8-14, 2021**

On March 9, 2021, Palmer Police arrested DYLAN POLLARD, age 23 of Wasilla, on a no bail warrant for Failure to Remand on an Original Charge of Theft 4. He was remanded to Mat-Su Pretrial.

On March 9, 2021, at 0615hrs, Palmer Police Department responded to a motor vehicle collision that occurred at S. Valley Way at the intersection of Evergreen Avenue.
