

PALMER POLICE PRESS RELEASES FOR
April 12-18, 2021

On April 13, 2021, Palmer Police arrested TYLER JEFFERY HANKS, age 27 of Willow, for Felony Driving Under the Influence and Misconduct Involving a Weapon in the Fourth Degree. HANKS additionally had three warrants totaling \$6,750.00 for Failure to Appear at a Bail Hearing, a Remand Hearing, and a Pretrial Conference. The Original Charges for these warrants were all Driving Under the Influence. HANKS was remanded to Mat-Su Pretrial to be held without bail until arraignment.

On April 14, 2021, Palmer Police arrested KOBIE T. TALBOTT, age 27 of Soldotna, on two \$7,500 warrants. The warrants were for Failure to Comply with Conditions of Probation on the original charge of Burglary 1 and Theft 2. He was subsequently charged with Misconduct Involving a Controlled Substance 4. He was remanded to Mat-Su Pretrial Facility.

On April 15, 2021, Palmer Police arrested MELISSA N. IMBODEN, age 26 of Palmer, for Driving Under the Influence and four counts of Endangering the Welfare of a Minor. IMBODEN was also cited for Driving with no Valid Operators License. IMBODEN was released on her own recognizances per the bail schedule.

On April 16, 2021, Palmer Police Summoned RONALD N. PALEN, age 59 of Palmer, for Driving Under the Influence and Misconduct Involving a Weapon in the Fourth Degree.

On April 16, 2021 Palmer Police responded to the intersection of E. Arctic Avenue and N. Valley Way for a reported motor vehicle collision. Investigation revealed a vehicle driven by HAWKE A. SPICER, age 23 of Palmer, struck a vehicle driven by HALI K. POTTER, age 30 of Palmer, when it entered the intersection without yielding the right of way. No injuries were reported. SPICER was cited for Failure to Yield To Vehicle Entering Intersection After Stop and POTTER was cited for Driving With License Revoked.

On April 17, 2021, Palmer Police arrested EUGENE D. WODKOWSKI, age 49 of Houston, for Driving While License Suspended and Violating Conditions of Release (DV). WODKOWSKI was remanded to Mat-Su Pretrial where he was held without bail, pending arraignment, per the bail schedule.

On April 17th, 2021 Palmer Police arrested KYLE L. ANDERSON, age 23 of Palmer, for two warrants, one for Failure to Comply with conditions of probation and Failure to Remand for his original charge of Theft 3rd. ANDERSON was remanded to Mat-Su Pretrial where he was held without bail per his warrant.

On April 17, 2021, Palmer Police arrested CARLOS R. GONZALEZ, age 42 of Anchorage, for Disorderly Conduct in the Fifth Degree. Bal was set at \$100.00 by Magistrate O'Brien.
