

PALMER POLICE PRESS RELEASES FOR **May 17-23, 2021**

On May 17, 2021, Palmer Police arrested AMY B. LALOR, age 40 of Palmer, for Assault in the 4th Degree Domestic Violence. She was remanded to Mat-Su Pretrial to be held without bail until arraignment, per the bail schedule.

On May 17, 2021, Palmer Police took a report of theft valued at \$250.00. The investigation is ongoing.

On May 17, 2021, Palmer Police arrested SHANE M. MADSEN, age 39 of Palmer, for Misconduct Involving a Controlled Substance 4, Driving While License Suspended, and No Motor Vehicle Liability Insurance. MADSEN was remanded to Mat-Su Pretrial where he was held without bail, pending arraignment, per the bail schedule.

On May 20, 2021, Palmer Police forwarded charges to the District Attorney's Office against DANIEL L. TROXEL, age 38 of Anchorage, for Criminal Trespass 1 DV.

On May 18, 2021, Palmer Police responded to a motor vehicle versus pedestrian collision at Bogard Avenue. and Glenn Highway. Investigation revealed a vehicle operated by ANTOINETTE J. MANCIN, age 67 of Palmer, failed to yield to MEGAN B. LASSELLE, age 26 of Palmer, who was in the crosswalk. LASSELLE received minor injury from the accident. Both parties exchanged information and left the scene.

On May 20, 2021, Palmer Police arrested WILLIAM C.L. JOHNSON, age 37 of Wasilla, on a \$50.00 warrant for Theft 4 and Criminal Trespass 2.
