

PALMER POLICE PRESS RELEASES FOR **August 2-8, 2021**

On August 3, 2021, Palmer Police arrested JESSY M. SCOTT, age 18 of Palmer, for Criminal Mischief in the 4TH Degree. SCOTT was remanded to Mat-Su Pretrial with no bail set per the bail schedule.

On August 3, 2021, Palmer Police issued a Summons to ASHLEY M. MILLER, age 35 of Palmer, for Disorderly Conduct.

On August 3rd, 2021 Palmer Police arrested JAMES P. D. COHEN, age 19 of Sutton, on a warrant for Failure to Appear for the original charges of Failure to Stop at the Direction of a Police Officer, Vehicle Theft 1st and No Motor Vehicle Liability Insurance. COHEN was remanded to Mat-Su Pretrial on \$1500.00 bail per the warrants.

On August 6, 2021, Palmer Police issued a Summons to ROSEBUD L. SWEENEY, age 30 of Wasilla, for Criminal Trespass 2. SWEENEY was released after the Summons was issued.

On July 30, 2021 Palmer Police received a report that a fence was cut and 260 feet of copper wire was stolen from Matanuska Electric Association. Following an investigation, on August 7, 2021, Palmer Police forwarded charges of Theft 2, Criminal Mischief 3, and Trespass 1 with the District Attorney's Office against WYATT L. WILLIAMS, age 40 of Wasilla. The value of the stolen wire was \$1974.00 and the cost to repair the fence was \$810.00.
