

## **PALMER POLICE PRESS RELEASES FOR** **August 30-September 5, 2021**

On August 30, 2021, the Palmer Police forwarded to the Division of Juvenile Justice a report of Criminal Mischief 3 against a 11-year-old male who caused \$1500.00 worth of damage to a camera at Swanson elementary school.

On August 30, 2021, HARMONY B. BAILEY, age 43 of Palmer, was issued a Summons for Criminal Trespass in the Second Degree.

On August 31, 2021, Palmer Police sent charges of Charges of Misconduct Involving Controlled Substances 3 to the Division of Juvenile Justice, against a 14-year-old female student who brought Marijuana and Marijuana paraphernalia to Palmer High School.
