

## **PALMER POLICE PRESS RELEASES FOR** **September 20-26, 2021**

On September 21, 2021, Palmer Police arrested DESTRY D. FARLEY, age 45 of Palmer, on a \$2,500.00 warrant issued for Failure to Comply with Conditions of Release on the Original Charge of Assault in the Third Degree.

On September 22, 2021, Palmer Police charged KELLEY W. KITCHEN, age 36 of Palmer, HARMONY B. BAILEY, age 43 of Palmer and BRANDON W. DREW, age 21 of Palmer, with Trespassing Second Degree. Charges will be forwarded to the Palmer District Attorney's Office for all three parties.

On September 22, 2021, Palmer Police received the report of a theft valued at approximately \$2500.00 and fraud for the value of \$100.00. The case is open and investigation ongoing.

On September 23, 2021, Palmer Police arrested SONJA J. YODER, age 32 of Palmer, on a warrant for Failure to Appear for Misconduct Involving a Controlled Substance 5. She was remanded to Mat-Su Pretrial where bail was set at \$100.00 per the warrant.

On September 24, 2021, Palmer Police responded to S. Alaska Street, just south of Cedar Avenue, for a motor vehicle collision blocking both lanes of Alaska Street. Officers photographed the scene and cleared the roadway. The drivers of the vehicles were identified as LEON KITAGAWA, age 51 of Palmer, and LORI IVEY, age 39 of Palmer. No injuries were reported.

On September 24, 2021, Palmer Police arrested DEREK HENSON on a \$250.00 warrant for Violation of Conditions of Release on Original Charges of Driving Under the Influence. He was remanded to Mat-Su Pretrial.
