

## **PALMER POLICE PRESS RELEASES FOR** **October 4-10, 2021**

On October 4, 2021, Palmer Police received a report of a past theft valued at approximately \$750.00. The case is open and investigation ongoing.

On October 5, 2021, Palmer Police investigated a fight which occurred on October 4, 2021, at Palmer High School. A charge of Assault 4 was sent to the Division of Juvenile Justice against a 15-year-old female student.

On October 5, 2021, Palmer Police received the report of a past assault. After completing an investigation, Officers have forwarded charges to the District Attorney's Office for DV Assault IV against SCOT M. SHUFORD, age 40 of Sutton.

On October 7, 2021, Palmer Police arrested ANTHONY C. PERKINS, age 26 of Palmer, for a warrant for Failure to Comply with Conditions of Release on the Original Charge of Misconduct Involving Controlled Substances in the 5<sup>TH</sup> Degree. He was remanded to Mat-Su Pretrial with bail set at \$500.00 per the warrant.

On October 7, 2021, Palmer Police issued a Summons to JACK L.K. TZOU, age 62 of Palmer, for a Hit and Run Collision.

On October 8th, 2021, Palmer Police arrested JESSE D. CHAMBERS, age 39 of Wasilla, for a warrant for Failure to Appear for the original charge of Driving While License Suspended. CHAMBERS was arrested and bail was set at \$100.00 per the warrant.

On October 8, 2021, Palmer Police arrested JAMES C. GEFFE, age 35 of Palmer, for a warrant for Failure to Appear for a Pretrial Conference Hearing on the original charge of Assault in the 4<sup>TH</sup> Degree. He was remanded to Mat-Su Pretrial with bail set at \$100.00 per the warrant.

On October 9, 2021, Palmer Police received the report of theft from a vehicle on S. Bonanza St. The total value of the items taken was approximately \$3,800.00. Investigation led to the arrest of JASON D. EASTHAM, age 28 of Palmer, for Theft in the 2<sup>nd</sup> Degree and Criminal Trespass in the 2<sup>nd</sup> Degree and the recovery of \$2,300.00 worth of property. EASTHAM was remanded to Mat-Su Pretrial where he has held without bail until arraignment.

On October 9th, 2021, Palmer Police arrested CASEY J. CARVER, age 16 of Sutton, for Driving Under the Influence. CARVER was arrested and released to a sober party.

On October 9, 2021, Palmer Police arrested CHRISTOPHER J. SKAGGS, age 42 of Wasilla, for Theft in the Fourth Degree and Violation of Conditions of Release on an original charge of Theft in the Third Degree. SKAGGS was remanded to Mat-Su Pretrial where he was held with no bail.

On October 10, 2021, Palmer Police arrested KATHERYNE L. MURRAY, age 32 of Wasilla, on a warrant for Failure to Comply with Conditions of Probation with the original charge of Harassment II. MURRAY was remanded at Mat-Su Pretrial with three days to serve per the warrant.
