

PALMER POLICE PRESS RELEASES FOR **November 1-7, 2021**

On November 1, 2021, Palmer Police arrested VICTORIA I. LAPORTE, age 26 of Palmer, on a \$100.00 warrant for Failure to appear for change of plea hearing with an original charge of Burglary 2, Concealment of Merchandise, Criminal Trespass 1, Theft 3 and Violating Conditions of Release, and another \$100.00 warrant for Failure to appear for change of plea hearing with an original charge of Concealment of Merchandise +3 convictions, Criminal Trespass 2 and Violating Conditions of Release. She was additionally charged with Criminal Trespass 2 and Violating Conditions of Release. She was remanded to Mat-Su Pretrial.

On November 3, 2021, Palmer Police received the report of Criminal Mischief at U-Haul causing \$2800.00 in damages to vehicles and Theft valued at \$375.00. The case is open and investigation on-going.

On November 3, 2021, Palmer Police arrested WAYNE I. JACKSON JR, age 20 of Anchorage, for a \$50.00 warrant for Failure to Appear with the original charges of Assault 4 and Criminal Mischief 4.

On November 3, 2021, Palmer Police issued a Summons to LINNUS A. DEPRIEST, age 63 of Palmer, for Criminal Trespass 2.

On November 4, 2021, TAMMY LESLIE, age 56 of Palmer, reported her vehicle stolen. Investigation continues.

On November 5, 2021, Palmer Police arrested AARON R. LASHBROOK, age 31 of Palmer, for Assault 3 and Criminal Mischief 5. He was remanded to Mat-Su Pretrial and held with no bail pending arraignment.
