

PALMER POLICE PRESS RELEASES FOR **November 22-28, 2021**

On November 23, 2021, Palmer Police arrested LAURA LEE ANN EVAN, age 23 of Wasilla, for Driving Under the Influence and Endangering the Welfare of a Child in the First Degree. Evan was remanded to Mat-Su Pretrial to be held until arraignments per the bail schedule.

On November 23, 2021, at 0901hrs, Palmer Police Department responded to Fred Meyers for the report of a theft. TYLOR M ANDERSON was contacted at Fred Meyers for taking \$53.41 in perishable items, TYLOR was issued a summons, and released.

On November 23, 2021, Palmer Police responded to the intersection of Arctic Avenue and Alaska Street for a motor vehicle collision. Charges have been forwarded to the District Attorney's Office for the MICS 4 and PETERSON was issued a summons for DUI.
