## PALMER POLICE PRESS RELEASES FOR November 29 – December 5, 2021

On November 30, 2021, Palmer Police forwarded a report of Misconduct Involving Controlled Substances 4 to the Division of Juvenile Justice against a 16-year-old female from an incident which occurred at Palmer High School on November 29, 2021.

On November 30, 2021, Palmer Police Department arrested ALADEAN MAREY, age 35 of Soldotna, on a no bail warrant for Obstructing Court Order with an original charge of Violating a Domestic Violence Protection Order.

On December 2, 2021, Palmer Police arrested ETHAN J. CONDIO, age 19 of Palmer, for Driving Under the Influence (DUI) of Drugs and Minor in Possession of Marijuana. CONDIO was issued a Summons for both charges.

On December 2<sup>nd</sup>, 2021 Palmer Police arrested DIANNE J. IVANOFF, age 23 of Palmer, for two charges of Domestic Violence Assault 4<sup>th</sup>, two charges of Domestic Violence Criminal Mischief 5<sup>th</sup>, and one charge of Violation of Conditions of Release. IVANOFF was remanded to Mat-Su Pretrial where she was held on no bail per the bail schedule.

On December 2, 2021, Palmer Police responded to the area of Glenn Highway and East Eagle Avenue for a single motor vehicle collision blocking the northbound lanes of Glenn Highway. Officers cleared the roadway and identified the driver as ANGELINA D. BLANCHARD, age 42 of Palmer. Minor injuries were reported, but medical treatment was declined at the scene.

On December 3, 2021, Palmer Police submitted a report of Assault 4 to the Division of Juvenile Justice, against a 15-year-old male, resulting from an investigation into an incident which occurred at Palmer High School on November 22, 2021.

On December 3<sup>rd</sup>, 2021, Palmer Police responded to the intersection of Glenn Highway and Dogwood Avenue for a 2 vehicle motor vehicle collision blocking the intersection. Officers cleared the intersection and identified the drivers as ETHAN G. LEAVITT, age 28 of Palmer, and BILL J. FASSER, age 56 of Palmer. Minor injuries were reported, but medical treatment was declined at the scene.

On December 3<sup>rd</sup>, 2021 Palmer Police arrested ETHAN G. LEAVITT, age 28 of Palmer, for Driving Under the Influence. LEAVITT was issued a Summons and released.

On December 3, 2021, Palmer Police arrested a 16-year-old Palmer resident on charges of Vehicle Theft 1 (DV), Assault 4 (DV), and Harassment 2 (DV). The juvenile was remanded to Mat-Su Youth Facility and held for the safety of the community.

On December 4, 2021, Palmer Police issued a summons to KELLY J. STRAWN, age 42 of Palmer, for Shoplifting Theft in the 3<sup>RD</sup> Degree.
