

PALMER POLICE PRESS RELEASES FOR **December 20-26, 2021**

On December 20, 2021, Palmer Police responded to a single vehicle rollover at Mile 40 of the Glenn Highway. The driver was identified as ROBERT VAUGHN WARNER, age 27 of Palmer. Investigation revealed WARNER had been under the influence of an impairing substance at the time of the rollover. Warner was issued a Summons for Driving Under the Influence.

On December 22, 2021, Palmer Police arrested JAMES J. MILES, age 36 of Anchorage, for Felony Driving Under the Influence and Felony Refusal to Submit to a Chemical Test. In addition, MILES had a warrant for Failure to Appear for Remand Hearing, original charge of Failure to Register as a Sex Offender and Violating Conditions of Release. He was remanded to Mat-Su Pretrial and held without bail until arraignment per the bail schedule and the warrant.

On December 22, 2021, Palmer Police arrested JANELL R. MURRILL, age 32 of Palmer, on a warrant for Failure to Comply with Conditions of Release on the original charge of Vehicle Theft 1. She was remanded to Mat-Su Pre-Trial where bail was set at \$250.00 per the warrant.

On December 23, 2021, Palmer Police responded to the intersection of Palmer Wasilla Highway and Glenn Highway for a 2 vehicle motor vehicle collision. The drivers of the vehicles were identified as CHRISTINA M. BORTZ, age 39 of Palmer, and NICOLE K. MEAD, age 34 of Palmer. Medical treatment was declined at the scene. Investigation revealed BORTS was Driving Under the Influence. BORTZ was issued a Summons and released at the police department.

On December 23, 2021, Palmer Police issued a Summons to STEVEN R. KAMMERMEYER, age 53 of Palmer, for Criminal Mischief in the 4th Degree and Assault in the 4th Degree.

On December 24, 2021, Palmer Police arrested GARY A. SAVOK, age 32 of Anchorage, for Driving Under the Influence. SAVOK was issued a Summons and released at the police department.
