

PALMER POLICE PRESS RELEASES FOR **January 10-16, 2022**

On January 10, 2022, Palmer Police forwarded a charge of False Report to the District Attorney's Office on TRINITY AHKPUK, age 19 of Palmer, in reference to a report of kidnapping and sexual assault made on December 28, 2021.

On January 11, 2022, Palmer Police arrested JERILYN T. MOORE, age 28 of Anchorage, for Assault 4. She was remanded to Mat-Su Pretrial where he was held without bail.

On January 12, 2022, Palmer Police arrested IVANA R. REED, age 29 of Sutton, on five warrants totaling \$1,150.00 cash; Failure to Appear for Arraignment, original charges of Removal of Merchandise and False Identification, Failure to Comply with Conditions of Release, original charge of Theft in the 3rd Degree, and Failure to Appear for Pre-trial Conference, original charges of Criminal Trespass in the 2nd Degree and Theft in the 4th Degree. She was remanded to Mat-Su Pretrial.

On January 12, 2022, Palmer Police arrested KELLY W. KITCHEN, age 36 of Palmer, for Driving Under the Influence. KITCHEN was issued a Summons and released on his own recognizance.

On January 13, 2022, Palmer Police arrested DYLAN W. LUNDQUIST, age 31 of Palmer, for Driving Under the Influence and Misconduct involving a Weapon in the 4th Degree. LUNDQUIST was issued a Summons for the charges and released.

On January 12, 2022, Palmer Police took a report of a theft and vandalism at the Palmer High School. During the winter break one of the ski team vans owned by PMNSTBC Inc. had a section of the muffler cut off and removed. Police are still investigating. Estimated damages and loss are \$1000.00.

On January 14th, 2022, Palmer Police responded to the intersection of E. Arctic Ave and S. Airport Rd. for a two vehicle motor vehicle collision blocking the intersection. Officers cleared the intersection and identified the drivers as RICHARD E. BRADFORD, age 77 of Palmer, and LYNNE M. ATKIN, age 68 of Palmer. No injuries were reported.

On January 14th, 2022 Palmer Police arrested JEREMY L. HERFINDAHL, age 31 of Wasilla, on a warrant of Failure to Comply with Conditions of Probation. JEREMY was remanded and bail was set at \$1000.00 per the warrant.

On January 14, 2022, Palmer Police arrested JAMES R. HANSELL on a \$500.00 warrant for Failure to Appear on an Original Charge of Driving Under the Influence. HANSELL was remanded to Mat-Su Pretrial.

On January 14, 2022, Palmer Police arrested ROBERT WAYNE MALONE, age 50 of Palmer, for Violating a Domestic Violence Protective Order. He was remanded to Mat-Su Pretrial where he was held without bail per the bail schedule.

On January 15, 2022, Palmer Police responded to the intersection of Rowland Memorial Way and Palmer Wasilla Highway for a three vehicle motor vehicle collision. The drivers of the vehicles were identified as RONDA N. BAUM, age 42 of Palmer, JESSE C. ALFRED, age 35 of Palmer, and KELLY L. WALLACE, age 55 of Palmer. On January 16, 2022, Palmer Police arrested SERGEY V. BOLOTOV, age 38 of Palmer, for Driving Under the Influence, Refusal to submit to a Chemical Test, Criminal Mischief 4, and Assault 4 (on a Police Officer). BOLOTOV was remanded to Mat-Su Pretrial where he was held on no bail.

On January 16, 2022, Palmer Police arrested THOMAS M. HENSEL, age 53 of Palmer, for Domestic Violence Assault in the Fourth Degree. HENSEL was remanded at Mat-Su Pretrial with no bail.
