

PALMER POLICE PRESS RELEASES FOR **January 24-30, 2022**

On January 25, 2022, Palmer Police charged ERIN P. SIMPSON, age 41 of Wasilla, with Leaving the Scene of a Motor Vehicle Collision and No Liability Insurance.

On January 25, 2022, Palmer Police arrested SHANE MICHAEL MADSEN, age 50 of Palmer, on two no bail warrants for Failure to Comply with Conditions of Release on Original Charges of Misconduct Involving a Controlled Substance 4 and Theft 4.

On January 26th, 2022, Palmer Police Department responded to the intersection of Anna Street and Bogard Avenue for a report of a motor vehicle that hit a pedestrian. Investigation revealed a vehicle driven by CAROL L. WITHEY (age 65) of Chugiak struck a 15 year old Palmer male as he crossed Bogard Avenue. Injuries were report and the male was transported to the hospital by a family member.
