

## **PALMER POLICE PRESS RELEASES FOR** **January 31 – February 6, 2022**

On January 31, 2022, Palmer Police arrested DIANNE J. IVANOFF, age 23 of Palmer, for Criminal Mischief 5 and Violation of Conditions of Release. She was remanded to Mat-Su Pretrial and held without bail pending arraignment.

On January 31, 2022, Palmer Police received a report of a theft of a handgun from a vehicle parked near Dimond Street and Elmwood Avenue. Estimated value of the handgun was \$500.00, an investigation continues.

On February 1, 2022, Palmer Police responded to a two vehicle Motor Vehicle Collision at the intersection of Arctic Ave and Bonanza St. The drivers were identified as RANDAL LEONARD FERRIS, age 66 of Palmer, and MEGAN NICOLE RICHARDS, age 23 of Chugiak. No injuries were reported.

On February 1, 2022, Palmer Police arrested LOGAN A. HARRISON on a no bail warrant for Failure to Appear for Remand Hearing on the original charge of Misconduct Involving a Weapon in the 3<sup>rd</sup> Degree, a \$250.00 Warrant for Failure to Appear for Sentencing Hearing on the Original Charge of Attempted Misconduct Involving a Weapon in the 3<sup>rd</sup> Degree and Violating Conditions of Release, and a \$250.00 warrant for Failure to Comply with Conditions of Release on the Original Charge of Driving Under the Influence. HARRISON was remanded at Mat-Su Pretrial on his warrants.

On February 3, 2022, Palmer Police, in conjunction with the McAllen Police Department in Texas and the Texas Department of Public Safety, arrested ANDREW K. DUNBAR, age 29 of McAllen, Texas on eight counts of Sexual Abuse of a Minor in the 1<sup>st</sup> Degree. This stemmed from an investigation conducted by the Palmer Police Department and members of the Alaska Bureau of Investigation. With the assistance of the McAllen Police Department in Texas and the Texas Department of Public Safety, DUNBAR was taken into custody near the border with Mexico. He is currently being held without bail pending an extradition hearing.

On February 5, 2022, Palmer Police forwarded charges to the District Attorney Office against LONNY P. MATTILA, age 45 of Palmer. Charges included Failure to Stop at the Direction of a Peace Officer, Assault in the 3<sup>RD</sup> Degree, Resisting Arrest, and Reckless Driving.

On February 6, 2022, Palmer Police arrested YULIANA V. SMITH, age 41 of Palmer, for Driving Under the Influence. SMITH was issued a Summons and released per the bail schedule.
