

PALMER POLICE PRESS RELEASES FOR **April 25- May 1, 2022**

On April 25, 2022, Palmer Police arrested CRAIG B. DUNYON, Age 39 of Wasilla, on a \$250.00 warrant for Assault in the 4th degree, Criminal Mischief in the 4th Degree, and Criminal Mischief in the 5th Degree. DUNYON was remanded at Mat-Su Pretrial.

On April 25, 2022, Palmer Police arrested JONNATHON S. STUDIE, age 31 of Palmer, on a warrant for Failure to Comply with Conditions of Release on the original charges of Violation of Conditions of Release, Theft 4 and Misconduct Involving a Controlled Substance 5. He was remanded to Mat-Su Pretrial where bail was set at \$100.00 per the warrant.
