

PALMER POLICE PRESS RELEASES FOR **May 9-15, 2022**

On May 9, 2022, Palmer Police Summoned CORY M. HOEL, age 30 of Wasilla, for Driving While License Suspended.

On May 9, 2022, Palmer Police Summoned ROURI T.E O'SHEA-GRANTHAM, age 37 of Anchorage, for Criminal Trespass 2nd.

On May 9, 2022, Palmer police took a report of Criminal Mischief 3 and Theft 2 from an incident which occurred on May 7, 2022, at Midas in Palmer. The report was that parts from a parked vehicle were removed and taken, causing damage to the vehicle. The value of the theft and damage was about \$1800.

On May 10, 2022, Palmer Police Summoned JESSIE E. MILLER, age 37 of Palmer, for Trespass 2.

On May 10, 2022, Palmer Police responded to the intersection of Arctic Ave and S. Alaska St. for a two-vehicle collision. The drivers of the vehicles were identified as MEGAN E. WORTHY, age 34 of Palmer, and SUSAN L. HELMERICKS, age 59 of Wasilla. Minor injuries were reported but medical treatment was declined at the scene.

On May 11, 2022, Palmer Police arrested KURTIS D. KEMP, age 33 of Anchorage, on a warrant for Failure to Comply with Conditions of Probation on the original charge of Forgery 2. He was remanded to Mat-Su Pretrial where bail was set at \$1000.00 per the warrant.

On May 12, 2022, Palmer Police Summoned RICHARD A. WEBER JR., Age 32 of Palmer, with Criminal Trespass in the 2nd Degree.

On May 12, 2022, Palmer Police arrested LINNUS A. DEPRIEST, Age 64, of Palmer, on a warrant issued for Failure to Appear for Arraignment on an original charge of Criminal Trespass in the Second Degree. DEPRIEST was remanded to Mat-Su Pretrial, and bail was set at \$50.00 per the warrant.
