

PALMER POLICE PRESS RELEASES FOR **June 20-26, 2022**

On June 21, 2022, Palmer Police arrested AMANDA A. GALT, age 48 of Wasilla, on a no bail warrant for Failure to Remand on original charges of Driving Under the Influence, Misconduct Involving Controlled Substances 4, and Endangering the Welfare of a Minor 1.
